Public Comments

1. Lenore Faulkner

XIII. New Business

A. Items Introduced by Superintendent

Dr. Grego's report included the following:

1) Shared that we celebrated educators last night at the Evening of Excellence and thanked the Pinellas Education Foundation for providing that opportunity. Dr. Grego stated that this event will also be highlighted on our website. Dr. Grego congratulated Joanne Wright, a reading teacher at Safety Harbor Middle School, who was named the 2013 Outstanding Educator of the Year for Pinellas County Schools, as well as the following five semifinalists: Jennifer Anderson, East Lake High School; Becky Bride, Palm Harbor University High School; Krista Kelleher, Sawgrass Lake Elementary School; Jennifer Klimis, Tarpon Springs Fundamental Elementary School; and, Jean Wark, Perkins Elementary School. Dr. Grego thanked the School Board and all the many business partners that provide support to this district.

2) Shared that the following two Pinellas County students were honored last week at the 2013 Sunshine State Scholars Program conference in Orlando: Mikayla Bridges, a junior at Seminole High, and Christina Tournant, a junior at Osceola Fundamental High. Dr. Grego stated that they joined other high-achieving Science, Technology, Engineering and Math students from around the state at the two-day event that celebrated the students' excellence in STEM studies and provided the opportunity for Florida colleges and universities to recruit their talent.

3) Shared that the following two Pinellas County schools have been recognized for their excellence by Magnet Schools of America: Douglas L. Jamerson Jr. Elementary was named

a 2013 School of Excellence and James B. Sanderlin PK-8 IB World School was named a 2013 School of Distinction.

4) Thanked the Board for attending the PASS breakfast last Friday. Dr. Grego stated that he will continue to encourage school leadership to reach out to businesses.

5) Shared that last Friday was his first experience with professional development activities in Pinellas County. Dr. Grego stated that as he visited various training sites, he was very impressed with the meaningful and productive activities taking place.

6) Stated that the Career Education Breakfast has been placed on the Board Members' calendar for March 22 at the Stavros Center. Dr. Grego shared that the Ford Motor Company will be naming Pinellas County as a Ford Next Generation Learning Community, one of only 17 communities in the nation, based on our district's commitment to align community resources to support the scaling and sustaining of high school Pinellas Academies. Most Board Members will be attending the FSBA Days in the Legislature and will be unable to attend this breakfast.

B. Items Introduced by School Board Attorney

C. Items Introduced by the Board

Ms. Clark - 1) Echoed congratulations to those recognized as outstanding educators at the Evening of Excellence. Ms. Clark stated that it was a wonderful event and thanked the Education Foundation for sponsoring that event.

Mrs. Lerner - 1) Stated that it was mentioned earlier that Pinellas has one of the lowest graduation rates but that this is not true. Dr. Grego stated that he will be providing clarifying information first thing in the morning. 2) Stated that our Teaching & Learning staff does so much on our Professional Development days. Mrs. Lerner shared that she had taken some out-of-town company to the Fine Arts Museum that day and ran into Ms. Sue Castleman, Supervisor K-12 Visual Arts, who had approximately 130 art teachers with her. Mrs. Lerner complimented all the Teaching & Learning supervisors for their work; and, stated that this demonstrates the collaboration that we have with our great community. Mrs. Lerner suggested that the Board receive information regarding next year's activities ahead of time so that, if they wish, they may visit some of the pro-ed day events.

Mrs. O'Shea - 1) Congratulated those teachers recognized at the Evening of Excellence, as well as all of our educators. 2) Questioned whether the scheduling of the lunch period for high schools could be a school-based decision for next year. Mrs. Cook and Mrs. Lerner agreed to schedule this for a workshop discussion. Dr. Grego stated that he will solicit input from the high school principals regarding this prior to the discussion.

Ms. Flowers - 1) Shared that she had a wonderful time at the Evening of Excellence event. Ms. Flowers stated that the event demonstrated to our teachers how much they are appreciated. 2) Stated that she participated on a panel, There's a King in Me, where she shared what growing up here in St. Petersburg was like. Ms. Flowers stated that this event was aimed at African-American males and females to encourage them to take personal responsibility and to cherish the education that is available to them. 3) Shared that she was the speaker at the debutant mother and daughter tea where, again, she had the opportunity to talk about the history. 4) Shared that during spring break, Girls, Inc., is having a Spring Break Chess Camp for Girls on March 25-29 for girls ages 5-17. Ms. Flowers stated that this camp's endeavor is to cultivate math skills, problem solving, etc., in the girls who will attend.

Mrs. Wikle - 1) Congratulated the Educator of the Year winner and semi-finalists. 2) Reminded all listening that there is great information to be found on our district's website.

Mrs. Krassner - 1) Congratulated all of our teachers and stated that the Board knows how hard they work. 2) Shared information regarding Ms. Flowers' involvement in the Merging Young Leaders where 20 young ladies prepared and delivered speeches. Mrs. Krassner stated that Ms. Flowers has been involved with this group for the past three years; and, expressed her pride in Ms. Flowers for her involvement in this program and the students who performed.

Mrs. Cook - 1) Congratulated those teachers recognized at the Evening of Excellence, as well as the students who spoke on their teachers' behalf. Mrs. Cook shared that excerpts from last evening's program may be viewed by going to the district's website. 2) Shared that the organization, Partnerships for the Advancement of Student Success (PASS), met this past Friday with Dr. Grego to determine how they can partner with the schools in giving of their talents in order to move our students forward. Mrs. Cook stated that this information is also available on our website.

Public Comments

Following the adjournment of the meeting, the following individuals presented their comments:

1. Rick Amstutz

Mr. Amstutz, teacher at Countryside High School, addressed the Board to say that there is not a sufficient supply of computers at his school; that there are only 145 seats in their computer lab; and, that they have to bring in a mobile lab to accommodate the approximately 2200 students on their campus. Dr. Grego stated that he had thought that all such requests from schools were addressed shortly after his arrival; and, that Norm Kelton and he will look into this matter.

2. Joe Morgan

Mr. Morgan addressed the Board to express his concern for the violent acts that bus drivers are exposed to every year; and, referring to a recent incident at Belleair Elementary School, suggested that there needs to be a process in place for students who are on buses when a lockdown goes into place. Mr. Bessette will provide the Board and Dr. Grego with more information pertaining to this recent issue.
