Program Description: The renewal of the agreement with the Department of Children and Families, Office of Refugee Services will continue implementation of a comprehensive education and training program for refugees and entrants in Pinellas County. The primary goal of this program is to promote economic self-sufficiency and to contribute to effective resettlement for eligible refugee/entrants. Funds are used to cover the costs of training and education for eligible students enrolled in district ESOL, AGE/GED, and vocational training classes for the target population. Funds are also used to provide marketing, case management, and support services.

Rationale: PREP is funded by the U.S. Department of Children and Families to work in concert with the U.S. Department of State and four local resettlement agencies (Catholic Charities,

Lutheran Services of Florida, Gulf Coast Jewish Family Services, and Coptic Orthodox Charities) to provide newly arriving refugees, asylees, and parolees with a variety services. PREP's main mission is to assist clients in achieving English literacy, career and technical training, and securing gainful employment with the ultimate aim towards self-sufficiency. There is no cost to PCS, and the program is vital to the success of refugees.

Students to be served/Target Audience: Refugees, Asylum applicants of all nationalities; Cuban/Haitian entrants; Amerasians; Certified Victims of Human Trafficking; lawful permanent residents who adjusted from prior refugee, entrant or asylum status and special immigrants of Iraqi or Afghan nationality, who have been in the United States for sixty months or fewer.

Performance Data, Research Findings, or Improvement Results: Approximately 128 clients are actively enrolled in classes at any given time. DCF directed performance measures for completion and retention were met or surpassed in every enrollment period with the exception of the capture of Literary Completion Points, which are anticipated to increase due to the new ESOL Distance Learning program, expanding enrollment, and frequency of CASAS testing.
