Program Description: The contract with Learning Sciences International (LSI) supports the development and implementation of the Teacher Evaluation Pilot project. The purpose of the pilot evaluation is to create a developmental evaluation model that accurately and fairly measures teacher performance while supporting the continued development of instructional practices with the overall purpose of raising student achievement.

The Florida Department of Education (FLDOE) approved the pilot evaluation system and has expressed interest in the process and results as a potential state model. The Pinellas County Teachers Association (PCTA) has been a collaborative partner in the pilot development process and attended all school presentations with district staff and building administrators.

The pilot will be conducted in five schools: Boca Ciega High School, Azalea Middle School, Gulfport Elementary, Seventy-Fourth Street Elementary, and Westgate Elementary School.

Following a presentation and an opportunity to understand the pilot, Instructional staff members in these five schools voted, all with over 80% approval, to participate in the pilot.

The funding includes professional development for administrators and instructional staff; technology integration; iObservation licenses; calibration; and development of the student performance measurements. The pilot is focused on building a meaningful evaluation system supporting Common Core State Standards (CCSS) implementation and the continual improvement of teacher practice. In addition, it is designed to build district and school capacity for lesson planning, unit development, use of formative assessment, and a culture of professional learning and continual development of instructional and leadership practice. The contract also includes the development of the student performance metric using multiple measures.

Rationale: The pilot evaluation project offers Pinellas County Schools the opportunity and support to develop a meaningful and effective teacher evaluation system that meets statutory requirements and provides for the continual development of teachers and leaders resulting in increased student learning. The pilot also provides for significant teacher involvement in the development of the units that will be used as a portion of their evaluations, giving teachers a larger control and influence over the student data and practice portions of their evaluation. The pilot, while focused on the target schools initially, also offers the potential for expansion across all schools in the future.

Performance Data, Research Findings, or Improvement Results: The pilot evaluation is based upon sound research principles and the Florida Department of Education approved Marzano framework for teacher evaluation. It is also supported by research indicating that multiple measures, including formative measures that inform practice, are more meaningful and effective measures of teacher performance than lagging indicators, such as the Value-Added score based upon FCAT, used alone. The project will be evaluated using quantitative and qualitative measures including teacher and administrator evaluation results, student performance results, teacher focus groups and student perception surveys.
