B: Request Approval of Supplemental Survey for Clearwater Fundamental Middle (Facility 47)

BACKGROUND:

The Educational Plant Survey for Pinellas County was completed in June 2010 and included site improvement, remodeling, renovation and new construction recommendations for Clearwater Fundamental Middle (Facility 47). This supplemental survey will allow the district to amend the Five-Year Capital Outlay Plan and Facilities Work Program, to include remodeling recommendations to construct a secondary exit into a separate atmosphere and remodeling the associated classrooms. Remodeling a food service cooler and freezer into kitchen office, kitchen garbage wash area and kitchen dry storage. Adding a new cooler and freezer unit and constructing a connection to the existing building. Attached is a copy of the supplemental survey that will be electronically submitted to the Florida Department of Education (FLDOE).

RATIONALE:

Based on input from the school and district staff, this supplemental survey, if approved by FLDOE, will better meet the needs of students and staff assigned to Clearwater Fundamental Middle. The recommended student stations will reduce to a total of 896 student stations. Recommended capacity of the school with FLDOE mandated 90 percent utilization factor will be 806. The Capital Outlay Full Time Equivalent (COFTE) Student Membership (enrollment) Recommended will decrease to 796.
