BACKGROUND:

The Educational Plant Survey for Pinellas County was completed in June 2010 and included site development remodeling, renovation and new construction recommendations for San Jose Elementary (Facility 102). This supplemental survey will allow the district to amend the Five-Year Capital Outlay Plan and Facilities Work Program, to include remodeling of old boiler room into an ESE Supplementary Instruction space, along with additional remodeling recommendations to reduce student stations and assist in balancing membership (number of students) being recommended for San Jose Elementary. Attached is a copy of the supplemental survey that will be electronically submitted to the Florida Department of Education (FLDOE).

RATIONALE:

Based on input from the school and district staff, this supplemental survey, if approved by FLDOE, will better meet the needs of students and staff assigned to San Jose Elementary. The recommended student stations will be decreased by 155 for a total of 448 student stations. Recommended capacity of the school with FLDOE mandated 100 percent utilization factor will be 448. The Capital Outlay Full Time Equivalent (COFTE) Student Membership (enrollment) Recommended will remain unchanged at 432.
