Program Description: IDEA, Part B, Entitlement project funds will be used to fund an Extended Transition Program for students with disabilities, age 18 to 22 years. Students will attend school at one of two sites: the Cultural Arts Center in St. Petersburg or Artists’ Studio in Dunedin, Florida. Pinellas County School Board will provide an appropriately certified exceptional student education (ESE) teacher and an ESE associate at each location. Transportation and food services will be provided by Pinellas County School Board. Creative Clay will provide a professional artist at each site for four hours each day. Quarterly student progress reports will be provided. In addition, instructional art materials will be provided. Creative Clay will invoice Pinellas County School Board monthly for services provided.
